The Lakewood Downtown Arts Festival, Inc., a non-profit organization, invites you to display and sell your art at the 35th annual Arts Festival.

The purpose of the one-day festival is to promote and encourage the arts in Lakewood, a community located along the shores of Lake Erie, as well as to share the exhibitors' exciting talents and expertise with our friends throughout the country.

The main street in the downtown business district will be closed to traffic and will be the site for our exhibitors. The festival is held outdoors and each artist should be prepared with adequate booth display covering in the event of inclement weather.

AWARDS AND JUDGING

\$1,300 in prize money will be awarded according to the decision of the judges. Prizes will be awarded without regard to artistic category. Of this money, there will be a first and second prize awarded for the most attractive booth display. The decision of the judges is final. Artist must maintain his/her booth during festival hours to be eligible for prizes.

ENTRY APPLICATIONS

Entry applications should be mailed to **LAKWOOD ARTS FESTIVAL**, P.O. Box 771288, Lakewood, Ohio 44107. The rental fee is \$100 for a 10' x 10' space, plus a \$10 non-refundable screening fee for CDs; \$20 fee for slides. Entries must be *received by* **March 15, 2012.**

Please include two separate checks or money orders with your application payable to LAKWOOD ARTS FESTIVAL **plus a stamped self-addressed envelope.** No cash, please. *Postdated checks will NOT be accepted.*

Acceptance and rejection notices will be sent out by April 1st. Rejection notices will be accompanied by a refund. **DECISION OF SCREENING COMMITTEE WILL BE FINAL.**

No more than one (1) space per artist. Use of space is restricted to the artist whose name appears on the entry application. *Subletting, selling, or giving of space to anyone will not be allowed.* Noncompliance will result in disqualification. Specific booth location requests cannot be guaranteed.

MEDIA

Ceramics, drawing, enamel, fiber, glass, graphics, jewelry, leather, metal, mixed media, painting, (oil, acrylic, pastels, watercolor), paper, photography, printmaking, sculpture, and wood. (Please note Item #1 under General Information.)

SLIDES OR DIGITAL PHOTO IMAGES

You have the option of submitting either slides or digital images along with your application. **Slides:** Three (3) 35mm slides representative of exhibitor's current work as well as a slide or photograph of your booth display.

Digital Images (strongly encouraged) of your current work and booth may be submitted via a non-returnable CD. Size: 1 megabyte, 72 DPI (no larger than 1024 pixels by 768 pixels in either direction) and must be SRGB color profile. Must be jpeg file and compatible

with Microsoft Picture Manager. No slide shows or outside publishing sources.

Please do not send photographs, brochures or actual work. Unless a self-addressed business-size envelope with sufficient postage is attached, slides will not be returned. The Lakewood Arts Festival assumes no responsibility for slides that are put in the provided return envelope and mailed. **NOTE: CD's will not be returned,** but you need to enclose a business size self-addressed, stamped envelope for entry acceptance or rejection. **If you send slides,** the envelope must be big enough and have enough postage to cover the return of the slides.

If accepted, exhibited work must be representative of slides or digital photos judged by the Board of Trustees Screening Committee.

GENERAL INFORMATION

1. All work must be original, priced, and signed by the artist. Please no kits, string art, velvet paintings, greenware, molded ceramics, or candles. All items must be original and/or hand-crafted.
2. All paintings, drawings and graphics must be framed, matted or displayed tastefully in a portfolio on an appropriate stand.
3. We reserve the right to remove objectionable art from the exhibit.
4. Exhibitor is responsible for his/her own display area which must fit within the 10' x 10' space and be strong enough to withstand wind and rain.
5. Exhibitor will take care of his/her own sales receipts and tax.
6. No commission fee is charged.
7. All exhibitors are required to carry their own liability insurance as the Lakewood Arts Festival, Inc. assumes no liability for damage, theft or injury on premises.
8. Due to the crowds and August heat, we strongly discourage your bringing any pets to the Festival.
